Malcolm will share some insights from his two-year journey with Christchurch Airport, including career highlights and challenges, and his thoughts about the future of Christchurch.

Chief Executive, Christchurch International Airport**



Malcolm joined Christchurch International Airport as Chief Executive in January 2014.

Prior to this role, he was Chief Executive of InterCity Group (NZ) Ltd for nine years, and Deputy Chair of Tourism New Zealand for six years to November 2013. He was appointed director of Tourism Industry Association of New Zealand in December 2013 and is the current chair of the New Zealand Airports' Association.

Christchurch Airport is a long-haul international airport servicing New Zealand's South Island. The South Island tourism industry generates around three million international passengers a year, supports 63,000 jobs and is worth circa \$6 billion per annum to the New Zealand economy.

Christchurch International Airport has assets of \$1.2 billion and a land area of around 840 hectares. A strategy reset in 2014 has seen 770,000 new airline seats added in the past 18 months (now totalling 7.7 million p.a.); the company has just launched an ambitious \$600 million property development programme over the next decade, with \$170 million in the pipeline in the next two years; and has moved to significantly lift dividend flows to shareholders over the next five years.
