Should Trading Charities pay Income Tax?

Michael works as an independent researcher and public historian (an academically-qualified researcher working outside a university). He has recently been appointed as an Adjunct Fellow at the University of Canterbury, a non-remunerated honorary role through which he hopes to work with humanities students on the erudite subject of fiscal sociology – the study of human behaviour in response to tax, as well as charity tax history.

One particular project he is working on, and which he will discuss, is a research paper on why trading charities in the UK are required to pay income tax and have done so since the 1920's, yet that is not the case in New Zealand, in spite of numerous tax reviews since 1967 arguing that such activity should be taxed.
