Dame Rosanne Meo ,DNZM, OBE

Dame Rosanne Meo has worked as a company director for over 20 years and was amongst the first professional women directors in New Zealand, the first woman to chair an SOE, [Forestry Corporation and TVNZ], and first woman chairman of a company listed on the NZSX. Rosanne was also the first woman Chair of the Employers Federation in the early 1990's.

She was knighted in early 2012 for Services to Business and for her contribution to not for profit organisations. She had earlier received and OBE in 1993.

Her directorships have been principally in New Zealand but also in Australia, and cover both public and private companies, as well as extensive work in the voluntary sector, particularly in the Arts and community support.

Previous appointments include, Chairman of TVNZ, Forestry Corporation, AMP NZ and Baycorp, and a Director of AMP Life [Aust], Ports of Auckland, Sky Television and Ceramco. Rosanne was also an inaugural member of APEC Business Leaders and a member of the Todd Task Force on Tertiary Funding.

She is currently Patron of the Auckland Philharmonia, Chairman of Briscoes Group, Chairman of the Real Estate Institute and AMP NZ's Staff Superannuation Schemes. She is

also a director of Overland Footwear and has recently retired from the Kelliher Trust and Middlemore Health Foundation. She chairs the AMP Scholarships Awards and has also been a judge of the Westpac Women of Influence Awards since their inception.
